Researcher Agreement

This Researcher Agreement ("<u>Agreement</u>") is between the University of Utah, for and on behalf of its Utah Museum of Natural History, also known as the Natural History Museum of Utah (the "<u>Museum</u>") and You (defined below) and sets forth Your rights and obligations with respect to Images and Data (defined below) You create from items in the Collection (defined below).

Additional Definitions

- <u>Collection</u> mean any artifact, specimen, label, catalog, associated record, and other material housed in the Museum's collections.
- <u>Image</u> or <u>Data</u> mean any resulting analysis, information and 2D or 3D representation in physical, electronic, or other format, that is derived by all past, current, and future use of items in the Collection.
- You or Your mean the person seeking access to the Collection and affirming the obligations contained in this Agreement.

In return for the Museum granting You (i) access to the Collection and (ii) permission to create Images or Data, You agree to the following terms and conditions:

Copyright

The copyright of all Images You create from any item in the Collection is the property of the Museum, regardless of whether You generate the Images on the Museum's premises or externally, unless otherwise specified in a separate written agreement between You and the Museum. To the greatest extent permitted by law, You hereby assign (and further agree to assign) to the Museum all of Your rights of copyright, in all images that You capture of or create from any item in the Collection, in all physical and electronic formats and all media, and any renewals, extensions, or revivals thereof.

Image & Data Submission for Collections Records

You agree to provide the Museum with a copy of all Images and Data You create that are derived from the Collection. For analysis conducted on Museum specimens, You agree to submit the raw data and a report summarizing Your results to the Museum Registrar (registrar@umnh.utah.edu) to become part of the relevant Collection's object's associated records. Please contact the Collections Manager in the collections corresponding to the artifact or specimens You researched in order to get instructions on how to appropriately share Your image and data files.

Attribution and Proof Submission

All reproduced Images must be given a credit line, preferably at the picture's edge. In the case of filmstrips or videotapes, credit may be listed in any accompanying brochure and/or in the film's credits. You agree to reference the full Museum catalog number, the Museum, and the land owner (e.g. land agency) agency (where relevant) in all means of dissemination (e.g. publications, reports, biorepositories, data aggregators, etc.) containing Images or Data derived from the Collection. (E.g. UMNH VP xxx, Courtesy of Natural History Museum of Utah (UMNH) & BLM)). You agree to verify proper attribution format with the Museum's Registrar prior to dissemination.

Final Product

Immediately upon publication, You agree to provide the Museum with one copy of the publication (book, audio or videotape, film, computer presentation, etc.) and/or electronic file be furnished at no cost to the Museum, sent to the Museum Registrar@umnh.utah.edu).

Creative Commons License

The Museum adheres to principles of openness in research based on the University of Utah's mission of education, research and public service. Consistent with these principles, for items in the Collection the Museum owns, manages, or is the copyright holder of, the Museum grants You permission to disseminate (with proper attribution) Images and Data You capture or create for scholarly or non-commercial use under a creative commons license, CC BY-ND. https://creativecommons.org/licenses/by-nd/4.0/legalcode.

Limited License

No rights, other than those expressly granted in this Agreement or by the creative commons license, are granted to You. The rights granted in this Agreement are granted only to You. You may not sublicense (e.g. grant permission to another person) Your rights under this Agreement.
